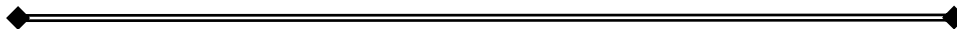

**GENERAL RULES AND REGULATIONS  
OF THE EASTERN NATIONAL  
LIVESTOCK SHOW, INC.**

In addition to these rules and regulations, exhibits and exhibitors are subject to applicable Junior Show rules and regulations and the rules and regulations of the Department and Divisions they exhibit in.

**MEMBERSHIP**

Regular membership dues are \$30 per year for farm/family membership, \$20 per year for individual membership, and \$10 per year for Junior Membership. Dues can be paid with entry fees. Make checks payable to "Eastern National Livestock Show, Inc." Dues are for year September, 2010 through August, 2011. **Each Exhibitor who enters the Eastern National Livestock Show must pay membership dues or pay non-membership fees.**

**LOCATION**

The Eastern National Livestock Show will be held at the Maryland State Fairgrounds at Timonium, Maryland, located on York Road (Maryland Route 45) eight miles north of Baltimore, Maryland. U.S. Interstate 83 runs adjacent to the west end of the Fairgrounds. To enter the Fairgrounds, exit Interstate 83 at Timonium Road, proceed east to York Road, then north to the Fairgrounds.

**MANAGEMENT**

All exhibits shall be under the direction and control of the Eastern National Livestock Show, Inc. The Eastern National Livestock Show, Inc. under no circumstances will be responsible for any loss, injury, or damage done to, or occasioned by, or arising from, any animal or articles on exhibition and the exhibitor shall indemnify Eastern National Livestock Show, Inc. and employees thereof against all claims on account of or resulting from the exhibitor's negligent handling of his exhibits.

**Any exhibitor or his representative or agent who violates any of these rules and regulations of the Eastern National Livestock Show, Inc., will forfeit all privileges and premiums and may be barred from future participation.**

The Eastern National Livestock Show, Inc. reserves the right to add to or amend these rules and regulations as the Board of Directors in its judgment may determine. These rules as amended will be posted in the show office and will be available for review by exhibitors during regular office hours.

The Eastern National Livestock Show, Inc., reserves to a committee of the Board of Directors the final and absolute right to interpret these rules and regulations and to settle and determine all concerns, questions, or disputes arising out of or connected with the Eastern National Livestock Show.

The Eastern National Livestock Show, Inc. reserves to a committee of the Board of Directors the right to inspect all animals entered in the show. Treating an animal, internally or externally, with an irritant or counter-irritant, or other substance to artificially change its conformation or appearance for a show is unacceptable. There will be no filling

by means of a stomach pump or drench. The use of inhumane fitting, showing and/or handling practices will not be tolerated. Any animal found to be erroneously entered or artificially altered by changing the natural conformation or the color of the hair, wool or hide in any way, shall be evaluated by this committee and any veterinarian or expert appointed by the committee. The committee is hereby authorized, in the event such an animal is declared to be erroneously entered or artificially altered, to bar such animals from competition in the Eastern National Livestock Show, and may bar the exhibitor who entered the animal, his manager or herdsman, or any and all from further participation in the Eastern National Livestock Show. Should the disqualification be determined following the awarding of any banners, ribbons, or premiums, the exhibitor of such animal, upon request of the Eastern National Livestock Show, shall immediately return same to show.

**No scales will be permitted on the ground except the official ENLS scales. Disclaimer: Announcements made at the ENLS, take precedent over statements printed in the catalogue. All Cattle Must Use Wash Racks at Cattle Pavilion.**

**"ANIMAL RIGHTS" DEMONSTRATIONS**

"Animal Rights" demonstrations are on the increase across the country. In case of a demonstration during the Eastern National Livestock Show, PLEASE follow the guidelines listed below:

- DO NOT debate with demonstrators
- REMAIN CALM if an event is disrupted
- DO NOT talk to the media regarding the demonstration.

Please alert the Show Officials to any questionable activities. A direct confrontation with demonstrators only insures them the attention they seek.

**EXHIBITORS**

Exhibitors participating in activities at the Eastern National Livestock Show are responsible to Superintendents of the Departments and Divisions in which they are exhibiting.

Exhibitors are responsible for the proper care of exhibits, equipment, and facilities. Superintendents reserve the privilege of ruling on any such cases

Disorderly or disrespectful conduct, drunkenness, or the possession or use of controlled dangerous substances (drugs) will not be permitted. All cattle exhibits must use tanbark, put in place by management.

Exhibitors must furnish their own straw for tie-outs.

Animals must be housed in space assigned by the Superintendent of the respective Department or Division.

All animals must be removed from tie-outs by 8:00 a.m. and are not permitted to tie-out until released time to be announced.

All animals must be available for use in judging contests if requested.

In accordance with the educational policies of the show, all weaning should be done prior to bring-

ing exhibits to the show.

**Please Note:** Children who have not reached their eighth (8th) birthday prior to January 1, 2010, may enter breeding cattle in any Open Class Breed Division; however, they may not exhibit or accompany the animal in the show ring. The animal(s) may be exhibited by a junior or adult over the age of eight.

Children who have not reached their eighth (8th) birthday prior to January 1, 2010, are ineligible to enter or exhibit in the Junior Heifer Division.

### **ENTRIES**

Entries must be made on printed entry forms furnished by The Eastern National Livestock Show, Inc., or on photocopies thereof. Entries must be made in accordance with the rules and regulations governing the show. **Entries will not be accepted unless all applicable information requested on the entry form is provided.** Exhibitors must have original registration certificate for all exhibits available at any time during the show. **Photocopies of registration certificates will not be acceptable. Copies of Health Papers must be submitted with entry.**

Every entry will be subject to the following stipulation: "I (we) hereby make application to enter the animal listed above for premiums at the 2010 Eastern National Livestock Show. I (we) understand that this entry is subject to the rules and regulations as published in the Premium List of said Eastern National Livestock Show and I (we) agree to the provisions contained therein. In consideration of the permission to participate in the Eastern National Livestock Show, I (we) for myself, my heirs, personal representatives and assigns, release, remise and discharge the owners of the premises, the sponsors of the Eastern National Livestock Show and their respective servants, agents, officers, and all other participants in the activities of and from all claims, demands, actions, and causes of actions of any sort, for injury sustained to my person and/or property during my presence on the premises and participation in the activities due to negligence or any other fault. **I (we) realize that if I (we) leave early, premiums will be forfeited.**

An exhibitor may enter any number in a class, however, only two entries in any class can receive premiums. Except where designated by breed associations, the number of classes and class designation will be determined at the discretion of the Superintendent of the Division. The same animal cannot be entered in both breeding and market classes.

There will be no entry fee or premium for any group classes. Premiums for cow-calf class in most breeds will be paid only by the Eastern National Livestock Show, Inc. All other entry fees are on a per head basis.

Individual animals to be shown in all group classes must have been entered and shown in the appropriate individual classes.

Substitutions may be made by the exhibitors within breed and must be the same sex as original entry. Substitutions must be filed with the Superintendent of the Breed not later than the time the animals are checked in. Such substitutions must comply with the same rules and regulations as all other entries.

### **OWNERSHIP**

Registration Papers from respective Breed Association dated prior to September 1, 2010. Only exception will be animals that are purchased through any sale, at Eastern National Livestock Show, which is sponsored by a Maryland Association.

**HEALTH REQUIREMENTS (All Livestock)**  
**Maryland State Vet 301-935-6074**

All entries must be accompanied by this Certificate of Veterinary Inspection (CVI) for show.

All out of state entries must be accompanied by an APPROVED interstate Certificate of Veterinary Inspection. An APPROVED copy of the certificate must be forwarded by the State of Origin to the Animal Health Section, prior to the arrival of the animals. The interstate (CVI) is only valid for 30 days from the date of issue. Health Section, prior to the arrival of the animals. The interstate (CVI) is only valid for 30 days from the date of issue.

Each animal must be identified on the certificates.

All animals will be inspected for general health upon arrival. Those showing clinical signs of ANY contagious or infectious disease must be removed from the Show or Fair. The State Veterinarian reserves the right to the final determination. In such cases the health certificate may be modified, suspended or revoked.

The CVI for Maryland exhibitors must be filled out and completed and signed by an accredited veterinarian within 45 days of the first exhibition.

Approval of all entries for the first showing in Maryland will extend in 60 day increments through the show season, providing that the status of the herd or animal(s) does not change. The CVI must be signed and dated on the reverse side by a MDA Animal Health Official at each event to extend the 60 day effective date.

Where immunization is recommended or required it must be done in conformity with standard procedures and practices consistent with the development of immunity PRIOR to Show or Fair.

All animals brought in for use in judging contests must meet the same health requirements as those coming on the premises for exhibition.

**NEWS RELEASE: NEW FAIR & SHOW REGULATIONS FOR LIVESTOCK EXHIBITORS (FEB. 21, 2008)**

Rules for the 2008 fair and show livestock exhibition season are now available from the Maryland Department of Agriculture's (MDA) website. [www.mda.state.md.us/animal\\_health/](http://www.mda.state.md.us/animal_health/). Hard copies will be available within the next couple of weeks and can be picked up at the time at one of MDA's five regional animal health diagnostic laboratories as well as the headquarters office in Annapolis.

New regulations this year include:

- Maryland exhibitors need to contact their veterinarian within 60 days of their first show to have their animals inspected and an Intrastate Certificate of Veterinary Inspection (CVI) completed.
- The Intrastate CVI is now valid for up to 180 days from the date of approval.
- Submit the appropriate copies of the CVI for approval to any of the regional MDA Animal Health Laboratories or the headquarters office in Annapolis within 30 days of inspection. One copy will be retained by MDA, the other re-

turned to the exhibitor.

- Self-certification of animal health. On the reverse side of the exhibitor's CVI hard copy or as a separate document downloaded from the MDA website in the "Livestock Exhibitor's Self-Certification of Animal Health" form. This form is to be filled out by the exhibitor prior to transporting their animal(s) to a fair or show stating that the animal(s) show no signs of contagious or infectious disease.

**CATTLE**

All cattle must have received and be so noted on health papers that they have received at least one dose of shipping fever vaccine or bacterin no less than 15 days prior to the opening day of the show, September 17, 2010. It is recommended that this prophylaxis include P13 and IBR and that booster doses be administered according to a veterinarian's recommendation. Leptospiroses immunization is recommended.

**BREEDING CATTLE**

Breeding cattle originating outside Maryland: (a) Must originate directly from a certified brucellosis free herd or be tested negative for brucellosis within sixty (60) days prior to the show. A test is not required on official vaccinates under twenty (20) months of age; (b) Must originate directly from a herd that has been tested negative for tuberculosis within the preceding twelve (12) months or be tested negative for tuberculosis within sixty (60) days prior to the show.

**STEERS**

Market cattle originating outside of Maryland must originate directly from a herd that has been tested negative for tuberculosis with the preceding twelve (12) months or to be tested negative for tuberculosis within sixty (60) days prior to the show.

**SWINE**

**HOGS**

Hogs originating outside Maryland must be accompanied by a health certificate signed by the veterinarian of the consignor.

A prior permit must be obtained from the state Veterinarian of Maryland for swine originating in a State where pseudorabies is known to exist.

The veterinarian's certificate accompanying pigs should include the owner's complete name, address, the identification number(s) of the pigs and the date of the veterinarian's examination.

**SHEEP**

All sheep, regardless of age or sex, must be from flocks registered in the scrapie control program and so identified by a) USDA approved tags, b) a legible registration tattoo, or c) an approved premise tattoo, before going to a Maryland fair or show.

#### **BREEDING SHEEP**

Breeding sheep originating outside of Maryland must have an interstate health certificate indicating that sheep for show and entire flock were examined within ninety (90) days prior to the show and no symptoms of infectious or communicable disease existed.

#### **MARKET LAMBS**

Market lambs originating outside Maryland must have an interstate health certificate indicating that sheep for show and entire flock were examined within ninety (90) days prior to the show and no symptoms of infectious or communicable disease existed.

#### **GOATS**

All goats, regardless of age or sex must be from flocks registered in the scrapie control program and so identified by a) USDA approved tags, b) a legible registration tattoo, or c) an approved premise tattoo, before going to a fair or show.

Breeding goat originating outside of Maryland must have an interstate health certificate indicating that goat for show and entire herd were examined within ninety (90) days prior to the show and no symptoms of infectious or communicable disease existed.

#### **PROTESTS**

The official judges will make awards in all classes.

*Excepting protests of possible erroneous entry or artificial altering of animals, all protests pertaining to eligibility must be submitted twelve (12) hours prior to the beginning of the judging. Protests for any altering or tampering of age shall be submitted within one-half (1/2) hour after the judging of the class involving the protest. A protest must be accompanied by cash or certified check in the amount of \$150 which will be refunded if the protest is sustained. Such protests must state plainly the cause of the complaint or appeal and be delivered to the Superintendent of the Department or Division within the time period stated.*

*The Superintendent will immediately report to the Executive Committee of the Board of Directors. Protests shall not be received or considered if they are based solely on a decision involving the accuracy of judgment on the part of the Judge, Superintendent, or the Committee. No complaint or appeal that judges overlooked an animal will be considered. Judging procedures will not be interrupted for protest investigation and depending*

*upon the basis of the protest, a decision may be withheld until a thorough investigation is completed.*

Open class Cattle and Feeder Steers Released at 9:00 PM (must be out by Sunday 8:00 AM if not staying for Junior Heifer Show).

#### **SUNDAY, SEPTEMBER 19, 2010**

All Junior Cattle Exhibits are released immediately following Selection of Supreme Junior Heifer.

All Livestock must be removed from the barns by 9:00 PM, September 19, 2010.

#### **JUNIOR RULES AND REGULATIONS OF THE EASTERN NATIONAL LIVESTOCK SHOW, INC.**

*In addition to these rules and regulations, Junior exhibitors and exhibits are subject to the General Rules and Regulations and the rules and regulations of the Department and Divisions they exhibit in.*

#### **ELIGIBILITY**

Members of National Junior Breed Associations must not have passed their twenty-first (21<sup>st</sup>) birthday prior to January 1, 2010, are eligible to compete in all Junior Activities. National Junior Breed associations will verify the age of their members if over Junior age limit.

## **EXHIBITORS**

Junior Exhibitors must be members of an organized Junior Livestock organization.

Junior Showmen members must be dressed neatly and cleanly while in the show ring. Exhibitors not complying with this rule may be excused from the ring at the discretion of the Superintendent.

All animals in Junior classes must be shown by the owner unless:

- a. Written notice from a Superintendent of another Department or Division certifies that said exhibitor is participating in another ongoing ENLS activity. This notice must be presented to the Superintendent of the show in question before animals may enter the show ring.
- b. The exhibitor is taken sick or is injured while at the Eastern National Livestock Show and is under a doctor's treatment: a written statement from a local doctor must be presented to the superintendent of the show in question before animals may enter the show ring.

In both cases above, another member of the exhibitor's family or another Junior Member of similar age (within two years of exhibitor's age) may show the animal(s).

## **ENTRIES**

Entries must be made on printed entry forms furnished by the Eastern National Livestock Show, Inc. or on photocopies thereof.

**Junior entries must be signed by the exhibitor, his parent or guardian who certifies that the exhibitor is eligible to compete in the Departments and Division entered.**

Each breed of cattle must have 15 paid entries to have a show. If fewer than 15 head show up, the show will still go on. If a breed has less than 15 head show up for two consecutive years, said breed will show under AOB.

### **RULES AND REGULATIONS**

In addition to the rules and regulations, exhibitors and exhibits in this Division are subject to the General Rules and Regulations.

Animals exhibited must have been the property of the exhibitor prior to September 1, 2010.

On each day of the show, cattle must be on display in assigned stall space from 8:30 AM until tie-out time is announced. There is no blocking chute charge, however, blocking chutes must be kept in designated areas.

Exhibitors must have the original registration certificate on each animal available for inspection at the show.

### **RULES AND REGULATIONS - (cont'd)**

Any animal upon check-in which does not have a legible tattoo corresponding to its registration certificate is ineligible to show. Once disqualified due to an incorrect or illegible tattoo, animals cannot be re-tattooed and rechecked at the show.

Only one person at a time shall lead animals into the show ring.

Any product administered internally or used externally to alter the conformation and/or appearance of an animal for exhibition is prohibited. The act of artificially filling animals internally, which would include stomach pumping, drench tubes, or any other method per os (by esophagus) is prohibited. Silicone injection or other injection for cosmetic purpose shall be prohibited. Anabolic steroid use shall likewise be prohibited and any animal testing positive for anabolic steroid or diuretic use shall be presumed to be altered and modified." This includes the covering of white skin, false tail heads (or use of any false hair), use of graphite, powders, hemp or other similar substances externally and steroids, growth stimulants or artificial filling internally. Any animal found to be in violation will be barred from showing. The exhibition of cattle displaying false hair will not be allowed.

ENLS requires that all animals be shown with a halter and suggest that all bulls be shown with a nose lead.

There are no entry fees for group classes and there will be no premiums for group classes or champions. Rosettes will be awarded to all breed champions and banners will be awarded to Grand and Reserve Grand Champions in each breed. Premiums will be paid uniformly across all breeds from Eastern National Livestock Show up to ten (10) entries in each individual class according to the following schedule:

Lambs must weigh a minimum of 80 pounds at the official weigh-in to be eligible for the show. Official weigh-in will be on Saturday, September 18, 2010 beginning at 8:00 AM, there will be no reweighs.

There will be no tolerance in class weights. However, an exhibitor with more than two (2) animals in a class may move the heaviest animal up.

Each exhibitor may show a maximum of seven (7) market lambs.

Lambs must have all their lamb teeth.

Both wether and ewe lambs may be shown. Unwashed sheep will not be allowed in the show ring. Lambs should be shown in short fleece. Lambs may be shown slick sheared. Lambs must be shown by the owner, except when two lambs are in the same class.

All lambs must remain on the fairgrounds and in their pens at all times, except when being moved to and from the show ring, wash rack, or to be trimmed on the trimming stands. Lambs cannot be housed or fed on trailers. Lambs must have clean bedding and may not be haltered, muzzled, or restrained in any other manner. Lambs should be fed and cared for in a humane manner. Any animal showing signs of physical or chemical altering may be banned from the show. Any exhibitor violating these rules will be immediately disqualified from the show.

Exhibitors leaving the fairgrounds early, without superintendent's permission, will forfeit all premiums and be disqualified from future shows.

In addition to these rules and regulations, exhibitors and exhibits in this Division are subject to the General Rules and Regulations and the Junior Rules and Regulations.

Market Hogs must be the bonafide property of the exhibitor and must have been owned for at least ninety (90) days prior to the opening of the show.

Each exhibitor is limited to a total entry of six (6) hogs. Both barrows and gilts may be shown.

A hog must weigh a minimum of 210 pounds at the official weigh-in in order to be eligible for the show. Official weigh-in for market hogs will be on Saturday, September 18, 2010 at 9:00 AM. If a question arises over the weight of the animal, that animal will be taken off the scale, the scale will be checked and balanced, and the animal reweighed immediately. An animal in question cannot leave the scale area until the dispute is settled. If an exhibitor leaves the scale area without registering a protest, the scale weight will be assumed to be correct. All disputes will be settled by the Superintendents and the weighmaster. All market hogs will be shown as individuals in classes determined by weight. Class breaks will be determined at the discretion of the Superintendents after all hogs have been weighed. An exhibitor may show as many entries as fall within an individual weight class; however, he shall receive premiums for the two (2) highest placing entries in each class.

No market hog will be allowed to be shown with any dressing of any kind (with the exception of plain water) other than the official paint brand.

Pen assignments will be made and posted at the Superintendent's office.

Pens must be cleaned prior to leaving show. If not, premiums will be forfeited.

Market Hogs released at conclusion of show.

Premiums will be paid to up to ten (10) entries in each class according to the following schedule:

**All Team Pure Bred Hogs may be shown in Junior Market Class. If shown in Pure Bred show and Market Hog show must pay entry fees for both Departments and must be entered separately.**

**GENERAL**

ABGA Sanction Show Rules shall govern each respective show. The American Boer Goat Association will accept and permanently record all wins in shows that have been determined to have met all requirements as stated below for ABGA Sanction. Failure to comply with ABGA Show Rules will result in the loss of funding and future sanctioning. ABGA requires that an ABGA Sanction Show Application be submitted to the ABGA office no less than 60 days prior to the show. **NO SHOWS WILL BE SANCTIONED DURING THE WEEK OF THE ABGA NATIONAL SHOW.**

**ENTRIES**

Any show receiving ABGA sanctioning shall be open to all exhibitors. There should be no limit on the number of animals that can be entered in a class by an exhibitor, unless the sponsoring show deems this limit necessary. Any show limiting the number of entries must state this in their rules. ABGA sanctioned shows cannot require animals to sell in a sale as a condition of participating in the show.

**ELIGIBILITY OF ANIMALS**

All goats must be registered in the herd book of a recognized association before time specified by the show. Recognized associations include ABGA, International Boer Goat, and the Canadian Boer Goat Association. Original registration certificates are required, though a copy of a Registration Application stamped with the date received by one of the

listed associations, can be accepted for kids less than 3 months of age. Animals must be registered in the name of the exhibitor and must have been owned by the exhibitor on or before September 16, 2010.

**\*\*THIS RULE WILL BE STRICTLY ENFORCED\*\***

**ENNOBLED HERD BOOK POINTS**

Only goats entered under their ABGA registration number and presenting their ABGA Certificate of Registration will be eligible to earn points for their actual placing in the show as described in the ABGA "Criteria for Ennoblement of a Boer Goat"

**TATTOOS**

All goats must have eligible tattoos or other means of permanent identification consistent with its registration certificate or the animal will be disqualified. The top 6 in the class plus the Champion and Reserve Champion goat's tattoos must be read and recorded. If the animal has a microchip as its permanent identification, the exhibitor is responsible for providing a microchip reader.

**COMPUTING AGES**

Birth dates, as listed on the registration certificate will be used to determine the class of divisions. Take the show date and count back to the birth date to determine the age and the class for the animal.

**CLASSES**

All animals must be registered purebred, full blood or percentage blood Boer Goats. Percentage doe classes are for goats 50% to 88%, Purebred/Full blood classes are for does that are 15/16 blood (94%) and higher 31/32 blood (97%) and higher for bucks. Progeny of fresh will NOT be allowed in the ring. At the discretion of the judge and the superintendent, goats may be let loose in the ring as a function of judging. The Champion and Reserve Champion classes will be chosen from the first and second place animals in that division of the show. Show committee reserved the right to combine or split the classes to accommodate the amount of entries.

**DISQUALIFICATION**

Any goat showing any pronounced defect or abnormality will be barred from the showing in any breeding classes. Artificial coloring will be a disqualification as well as illegible tattoos or tattoos that are inconsistent with the goat's registration papers. Any doe over 24 months of age that has not kidded and cannot prove a current pregnancy will not be allowed in the show.

**ENTRY FEES**

K-1 and K-2: Entry fees will be \$12.00 per head, per show or \$20.00 per head for both shows and a pen charge of \$5.00 per pen. Fees are due at the time the entries are mailed. Checks are to be made payable to ENLS and mailed with entry form to the

address on entry form. (THIS IS NOT A TRAILER SHOW. ALL ANIMALS MUST BE CHECKED IN AND UNLOADED TO PENS. NO EXCEPTIONS!)

K-3: Entry fee will be \$12.00 per head. No association affiliations required. Show is open to Does and Wethers. Does and Wethers will be shown separately. No weight limit and no limited on number of animals entered. Goats must be entered prior to weigh in and can only have one weigh in.
